## **Eligibility Requirements:**

Under CFH, beginning with the 2018-2019 award year, a Pell-eligible student whose parent or guardian died in the line of duty while serving as a public safety officer is eligible to receive a maximum Pell Grant for the award year for which the determination of eligibility is made. All Title IV aid awarded to such eligible students must be based on an EFC of zero without regard to the student's calculated EFC.

To qualify, a student must be Pell-eligible and have a Pell-eligible EFC for an award year, and be less than 24 years of age or enrolled at an institution of higher education at the time of his or her parent's or guardian's death. In subsequent award years, the student continues to be eligible for CFH, as long as the student has a Pell-eligible EFC and continues to be an eligible student.

For the purpose of CFH, a public safety officer is:

- As defined in section 1204 of title I of the Omnibus Crime Control and Safe Streets Act of 1968 (42 U.S.C. 3796b); or
- A fire police officer, defined as an individual who is serving in accordance with State or local law as an officially recognized or designated member of a legally organized public safety agency and provides scene security or directs traffic in response to any fire drill, fire call, or other fire, rescue, or police emergency, or at a planned special event.
