## **GMAT FEE WAIVER**

Students may apply for GMAT Fee Waiver through the Financial Aid & Scholarship Office. There are a limited number of GMAT Fee Waivers which will be available on a first-come, first-served basis. The fee waiver is good for the entire GMAT fee.

Candidates accessing the GMAT via an in-person testing center must register and take the GMAT exam no later than September 2, 2023. Candidates accessing the GMAT via the fully online testing option must register and take the GMAT exam no later than November 15, 2023.

## To be eligible you must:

- Have completed a minimum of 60 semester units.
- Students must have a current year FAFSA on file with Chico State that demonstrates a high financial need, as determined by the Financial Aid & Scholarship Office.
- CADAA applicants are not eligible to apply. If you are a CADAA applicant, contact the Graduate Studies office to inquire about additional resources.

To apply for a GMAT Fee Waiver, please complete the application form and email or fax it to the Financial Aid and Scholarship Office. It will take a minimum of five business days to process your application. An email will be provided regarding the status of your GMAT Fee Waiver Application.
