



Conduct Curriculum Guidelines for Residential Students

As a member of University Housing (UH), you will be held accountable according to the policies outlined in the “University Housing Policy Guide.” Below is a table that exists as a general guideline for the Residence Conduct Coordinators and Coordinator for Student Conduct and Community Responsibility to serve as a tool for consistency. This table reflects the UH Policy Guide sections and serves as a visual for residential students. Students are also subject to the policies outlined in Title 5, Title IX and may be referred to Student Judicial Affairs as appropriate. The table is not linear – based on the severity of the situation all sanction(s) are possible at any time, and individual circumstances may merit heightened or lessened outcomes.

In addition to status (Hold, UH Probation, UH Termination) and educational sanction(s), restitution for the damage caused may be applied for biohazards, elevator damage, community damages, etc.

Important terms in the UH conduct process

Warning – The situation has been documented and kept on file but no further educational sanction(s) are assigned at the time. A warning may be given verbally in a meeting or in writing through a letter.

Educational Sanction(s) – These are assigned with the goal of the student learning more about UH policies, the university, themselves, or their choices. These may include research or reflection papers, creating educational materials, engagement with other offices on campus, positive participation in the community, or other sanctions dependent on the situation.

Fines- Previously established and published fines may be imposed.

Hold – Failure to meet with an RCC or failure to complete assigned sanctions by the deadline may result in a hold being placed on the student’s account. A student can check for a hold by logging in to their CSU Chico Portal.

Restitution-Compensation for loss or damage. This may take the form of appropriate service and/or monetary or material replacement.

Relocation – University Housing reserves the right to relocate a resident to a different community if their behavior is proving detrimental in their current residence. Relocation from one community may also include a ban from that community within a given time frame.

Risk of UH Probation – Notification to student that due to their behavioral history they are nearing UH Probation.

UH Probation – Any further violations of the UH Policy Guide may result in termination of the student’s license agreement. When a student is placed on UH Probation, they are also required to complete a paper detailing how they will remain a student if they lose their housing.

UH Termination – The process will be initiated to end the student’s license agreement. The student will generally have 72 hours to vacate their room and turn in their keys. Terminations are determined by the Associate Director for Residential Life and Coordinator for Student Conduct and Community Responsibility.
