## Spring 2010 University Housing License Cancellation Form

University Housing and Food Service must receive the cancellation in writing for the Spring 2010 University Housing License **by 5:00pm on December 18, 2009** in order for you to receive a refund less \$5.00 processing fee.

*Please note: If you are only canceling University Housing but will still attend CSU, Chico; please make sure you check the box labeled "Apply Payment to University Account" on the Cancellation Form. This will apply your University Housing payment to your student account and help you avoid additional fees or time delays in the payment of your Tuition and Registration due December 10, 2009.*

Below are the different methods of payment and the refund procedure for each:

**Personal Check** – If payment is received by paper check, there is 3-week clearance period for the University to verify that your payment was cleared by your bank. When a refund is requested, receipt of fund is first verified and the refund check is then processed. This process can require 4-6 weeks. The refund check is made payable to the Licensee (student) and sent to the address on file with the University. A \$5.00 processing fee is assessed by Student Financial Services for this service.

**E-Check** – If payment is received via E-check the process is exactly the same as above. You will receive a University check sent to the address on file with the University and the \$5.00 processing fee would apply.

**Credit Card** – If payment was made via credit card, the 3-week verification of funds does not apply. Student Financial Services will issue a credit to the credit card used for payment, in approximately 10-15 business days. The 2.9% transaction fee assessed on all credit card payments is "**non-refundable**" and the \$5.00 processing fee also applies. See the example below for further illustration:

Example:

Payment of \$1000 is received via Credit Card.

The amount assessed to your credit card is \$1029.

Upon receipt of refund request CSU, Chico credits your credit card for \$995 (\$1000 less the \$5 processing fee).

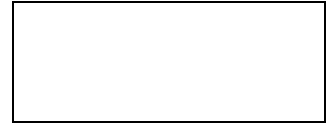
### Important Note:
