The Bachelor of Arts in Geography at California State University, Chico was established in 1964 and has been in place since that time.

 History of the program, including its status as a major, option, minor, credential, or certificate,

In 2000-05, the curriculum was redefined to integrate the human and physical options where students from both options would take more classes together than in the past. The two current options (Human Geography and Planning AND Physical and Environmental Geography) came into being following the name change of the two patterns of Human Geography and Environmental Geography by EM 04-021 on 15 June 2004.

- o Relation to other programs, including General Education, and
- o Status as a professional or pre-professional program.

Planning has been a key component of the department since the 1970s and the establishment of the geographic information systems lab and hires with expertise in both planning and geospatial technology fields in the 1980s and 90s allowed the curriculum to address environmental questions with a focus on environmental analysis and environmental and policy questions. The development of two certificates in Geospatial Technologies and Land Use and Environmental Policy have benefitted not only our own graduates, but students from disciplines and colleges across campus. Many of our courses are required or electives in other programs across campus.

Geography has always been well integrated into general education with GEOG 101W as a foundational course in six of the ten general education pathways before 2021 and the Fall 2021 GE redesign, and LD courses in Area D (GEOG 102, 103, 105 and 106) in Diversity Studies Pathway, Food Studies, Great Books and Ideas International Studies and Science, Technology & Studies Pathways. and Area C (GEOG 139); Global Cultures designation GEOG 102 and US Diversity (GEOG 105). Upper division D GE courses included GEOG 352 (USD), 301W (GC), GEOG/LAST 357 (GC), GEOG 303 (GC), GEOG 304 and GEOG 305 across six of the ten pathways. Geography has remained well situated within GE since.

Changes to general education following the WASC accreditation review in 2019 and subsequent changes to GE modified the designation of Area D1 and D2 into a single Area D designation and reduced requirements from two LD Area D courses to one have negatively impacted the enrollment in general education in geography. Geography tends to be a 'discovery' degree whereby students 'find' the major through their general education courses. Structural changes in GE that increased enrollment in the past for geography have in recent years resulted in diminished enrollment in geography due to reductions in general education requirements, structural changes, agreements with community colleges all while the number of general education courses offered across the university were increased.

The department supports the University's strategic priorities of resilient and sustainable systems and mission through a curriculum that emphasize understanding, mitigating, and planning for social, economic and environmental sustainability and climate change. The collaboration with the community, county and state through experiential and service learning projects and faculty involvement in civic affairs support the civic and global engagement strategic priority. Our innovative and high quality teaching, research and service with the focus on integrating social and environmental issues that is key to our teaching all our teaching and research.

• Who was it designed to serve (describe the student need)? What are the societal needs? (E.g., cultural, technological, economic, artistic, scientific). Are similar programs available elsewhere in the CSU?

Three CSU campuses in Northern California (excluding the Bay Area campuses) offer BA or BS in Geography (Cal Poly Humboldt, CSU, Sacramento and CSU, Sonoma). UC Berkeley offers a BA in Geography. See the Landscape Geography Option for the specifics of these programs.

This request to discontinue the program is part of an effort to re-envision and update our program and curriculum as it is currently offered. This request submitted simultaneous with the Proposal for a New Option in Landscape Studies in Geography. Our proposed new option in Landscape

Studies in Geography will replace the two current options (Option in Human Geography and Planning and Option in Physical and Environmental Geography), with a single Option in Landscape Studies that further integrates the two pillars of geography (human and physical) in a single 24-unit core. We have streamlined our courses and focused our curriculum into three application domains: Sustainable Planning, Landscape Analysis and Visualization and Landscape Stewardship.

What efforts have been made to sustain or improve the program? If there have been no efforts, please explain why efforts have not been made to improve the program (including suspension for purposes of re-evaluation [EM 13-057]).

We have had ongoing efforts to sustain or improve the program. In 2016, a minor in Geospatial Literacy was approved by EM 16-001. This minor includes four core geography courses and six electives from nine programs across campus. The minor has been a way to attract students from other disciplines who are interested in learning and/or using GIS and geospatial analysis in their research and frequently students will also complete the GST Certificate.

The department has developed Instagram, Facebook, and Linked In social media accounts to promote geography as a discipline and our major, minors, and certificates to potential students at Chico State, as well as high schools and community colleges in the North State. In spring 2020, we were the client for JOUR 344 Public Relations Strategy course.






The following spring, we contracted with the Tehama Group Communications to develop logos, social media accounts and a plan for promoting geography. We have hired a PR intern since that time to develop content for social media which will be directed to promote our proposed options. The College of BSS has been supporting this curriculum redesign. During fall 2022, we met weekly with a consultant in the development of the proposed curriculum redesign. Several changes have been made or are currently in curriculum approval process to sustain or improve the program.

Additionally, we have revised our curriculum in several ways to make it leaner and potentially more appealing to students. We have renamed several courses, removed pre-requisites, and eliminated courses to reduce redundancy and some offerings that are typically major specific.

How many students does the program serve? What are recent trends in enrollment? What is the external demand for the program from an employment perspective?

This proposed package is in response to declines in the number of majors, FTES and enrollment that we have experienced in the past few years. The enrollment in the two options (Human

Geography and Planning and Physical and Environmental Geography) peaked in 2011-12 with 94 majors in the fall semester. Enrollment has declined in the last few years with 56 majors in fall 2016-17 to the current number of 30 majors in Spring 2023. Declining enrollment following the Camp Fire in fall 2018 and through the Covid pandemic have been challenging for our small department.

• What are the shortcomings of the program that have led to the proposal to discontinue? (What criteria were used to gather data on the program? How was the data

assessed? Has the program been through a five-year review? If not, why not? If so, what were the results of the last review?)

The largest factor in this proposal to discontinue the proposal is a lack of faculty to provide support to innovative new course offerings. In consideration of the most recent five-year review, the department has lost four faculty to retirement and gained one. Similarly, our graduate program was suspended, and some natural support and recruitment interest concomitantly declined. The small faculty pool is taxed to support remaining courses, particularly where expertise may be lacking. The fire year review identified the need for hiring a physical geographer to fill a curriculum void created by attrition.

• Describe current staffing levels, FTES and other information relevant to program performance.

There are currently seven tenure/tenure-track faculty in the department; five full professors, one associate and one assistant; one ASC I, one student assistant and a student public relations intern. We currently have five lecturers. We currently have five lecturers that teach from 3 WTU to 8.6 WTU.



The largest factor in this proposal to discontinue the proposal is a lack of faculty to provide support to innovative new course offerings. In consideration of the most recent five-year review, the department has lost four faculty to retirement and gained one. Similarly, our graduate program was suspended, and some natural support and recruitment interest concomitantly declined. The small faculty pool is taxed to support remaining courses, particularly where expertise may be lacking. The fire year review identified the need for hiring a physical geographer to fill a curriculum void created by attrition.

There are currently seven tenure/tenure-track faculty in the department; five full professors, one associate and one assistant; one ASC I, one student assistant and a student public relations intern. We currently have five lecturers. We currently have five lecturers that teach from 3 WTU to 8.6 WTU.
