Enclosed is the report concerning the review of your *specialist* program by the National Association of School Psychologists (NASP). Reviewers with training in the application of the NASP *Standards for Graduate Preparation of School Psychologists* evaluated your submission followed by review of the site visit team in Spring 2023. A full submission will be required for your next program review using the NASP Standards for Graduate Preparation of School Psychologists and according to the instructions and deadlines located on the NASP website at https://www.nasponline.org/standards-and-certification/graduate-program-approval-and-accreditation.

Your next submission for NASP accreditation will continue to require that you use the NASP online process. We encourage you to visit our website often to review any updates about the online submission requirements, as well as procedures for program assessment of candidates and other program activities that will be needed for an online submission.

Your next NASP program review will require that you provide evidence that your program meets the most current NASP standards. In the next year, we encourage you to check our website often for information concerning the revision of the NASP standards, so that you may begin any needed program modifications to meet the new standards. In addition, the NASP Program Accreditation Board continues to provide training to graduate programs at the NASP convention. We encourage your program to attend the sessions provided to all programs.
