



CSU Chico ADA Transition Plan 2016-2017 Progress Report

The following summarizes CSU Chico's efforts to remove physical accessibility barriers during the 2016-2017 academic year.

Restrooms:

- Esken and Mechoopda first floor bathrooms provide ADA compliant shower and toilet on both wings
- Warren Center ADA restroom accessibility upgrades
- Glenn 2nd Floor Restrooms-complete renovation for accessibility and finishes

Signage:

- Campus way finding and signage – Kendall Hall corridors and exterior way finding installed along the first street corridors and south side of the creek
- Access signage for Holt and Plumas elevators

Hydration Stations:

- Acker 1st Floor Hydration Station - Upgraded to bi-level fountain and added hydration station.
- Ayres 1st Floor Hydration Station - Upgraded accessible fountain and added hydration station.
- Butte 1st Floor Hydration Station - Upgraded to bi-level fountain and added hydration station.
- Butte 3rd Floor Hydration Station - Upgraded to bi-level fountain and added hydration station.
- Holt 2nd Floor Hydration Station - Upgraded to bi-level fountain and added hydration station.
- Meriam Library 1st, 2nd and 4th Floor Hydration Stations - Upgraded to bi-level fountains and added hydration stations.
- Performing Arts Center 1st Floor Hydration Station - Upgraded to bi-level fountain and added hydration station.
- Shurmer 1st Floor Hydration Station - Upgraded to bi-level fountain and added hydration station.
- Tehama 1st Floor Hydration Station - Upgraded fountain for standing-persons and added hydration station.

- Tehama 3rd Floor Hydration Station - Upgraded fountain for standing-persons and added hydration station.

Building Entrances:

- Adjusted BMU doors to comply with accessibility requirements (pounds of pressure)
- Automatic door opener installed at the West entrance of the Student Health Center

Other Improvements:

- Acker 128 Strength & Conditioning Center - The new training space is barrier-free and include an accessible fountain with hydration station.
- Physical Science building emergency vehicle access bridge
- Holt 266 & 268 seating replacement
- Plumas Courtyard ramp replacement
- Stadium Track Resurfacing - Eliminated raised and damaged edges along west side of track.
- Many hands free devices installed in RR's over the campus have been adjusted to meet ADA requirements
- Removal of bike rack in front of Student Services Center to allow improved path of travel

Ay 2017-2018 plans:

- Glenn elevator upgrade
- Acker gym - replace south bleachers
- Acker Gym - 1st floor main restroom upgrades
- Revise/Develop updated Transition Plan
- Yolo Parking Lot - Path of Travel Improvements
