- *It is engaging to students and to a broad audience.* Well-written and researched, this book tackles an issue that is deeply important as our community and country confront an opioid epidemic made considerably more urgent by the COVID-19 pandemic and the pressure put on the healthcare system and first responders.
- *It has broad appeal across disciplines.* This book, with its focus on individuals as well as the healthcare system and pharmaceutical industry, will be relevant to a wide array of disciplines including medicine/nursing, psychology, public health, political science, and legal studies.
- *It is relevant and timely.* Butte County has seen a large rise in deaths from opioids since 2018, and this is true for Chico State's larger service region. This book would open the door for other conversations about addiction, the role of the pharmaceutical industry, as well as the work of the healthcare system, healthcare providers, public health workers, and community activists.
