
How Market Match is Utilized

 At farmers' markets, CalFresh EBT
(CF) is matched \$1 for \$1 up to a daily maximum, which is \$15 at most sites.

 Eligible foods that customers can buy with Market Match (MM) is fresh or dried fruits and vegetables and edible plant starts.



Total CalFresh EBT & MM Funds Distributed at Farmers' Market sites (n=11)






2021 vs. 2022

- 2022 was the first year CHC operated EB.
- Each partnering organizations receives a set amount of FMNP check booklets for the year from the state and in part the number they receive is based on the FMNP redemption rate of the previous year.
- The Senior FMNP program had not operated since 2019 due to the pandemic.

- The EB program reached 1,467 individuals/households, which is 90% of the project goal number of individuals/households reached.
- The 2022 EB program ends 3/31/2023 and then EB reimbursement numbers will be shared.
