For those of you interested in fulfilling a **depth core requirement**, or who are interested in the **Child Development Permit**, **CHLD 456 Administration of Child Development Programs: Advanced** (3 Units) is offered this spring 2023. This is one of the administration classes for the **Child Development Site Supervisor** for the Child Development Permit. The other course for the Site Supervisor is CHLD 462, Adult Supervision in Child Programs: Advanced, typically offered every other spring on even years.

Prerequisites: CHLD 252 and 251, junior standing. **Typically Offered:** Spring only odd years, online asynchronous

Course Description: This course focuses on the role of the program administrator in various types of licensed child development facilities. Topics include programming, fiscal oversight, licensing regulations, personnel decisions, legal issues, and management aspects of children's programs. 3 hours seminar.
