# Cal Employee *CONNECT*

Cal Employee *CONNECT* is a secure, web-based employee self-service portal accessible to employees. Access to password protected/secure areas of this portal is restricted to authorized users only.

To Register, go to <https://cecpilot.sco.ca.gov>

1. Have a recent paper pay stub in hand (see back for more details)
2. It has information you will need that is not available from Payroll or the Chico State Portal
3. Be a state-side employee
4. Go to Cal Employee Connect
5. Select "Register"
6. Follow the prompts to register using your campus or personal email account
7. Once registered, you will be able to login to:
  - a. View and print your earnings statements/paychecks: current tax year and 2 tax years prior
  - b. View and print W-2 information: 3 years are available
