This was created to be helpful and to stay apprised of needs but it has been difficult to fully recognize the full potential of this process in the absence of full participation and efforts to return the completed the forms. Note that while this process does not guarantee a funding increase a \$250 increase for Literary Editing Programs Watershed Review this year was the direct result of working with them based on submission of the requested information.

As has been explained to the IRA Board in previous discussions:

The use of HFA discretionary funds has been challenging to communicate each year from the beginning with each iteration of IRA board and staff members who appear to be suspicious initially of our use and need for a substantial buffer. We understand but to be clear, HFA is not hoarding funds. The buffer or practice of "cushion budgeting" to protect against unexpected change in plans or emergency occurrence's is one part of it.

We use discretionary funds to take into account a possible unplanned drop in ticket revenue to ensure a balanced budget and as insurance should problems arise or special opportunities or requests come up, in which case we'll assess and allocate to be sure that programs are balanced. Should any number of things fail and prevent successful execution of a production and revenue from ticket sales we must still be able to cover the resultant negative. Of particular importance to note regarding our discretionary usage is the fact that our productions involve negative spending through the year that is balanced by ticket sales. For example, materials and student labor to build a set, costumes, install lighting and audio, building and purchasing props, paint, special EFX supplies, rentals etc. for each production is a laborious process that requires expenditures preceding the actual productions by months.

Since many of our IRA programs share spaces and equipment for performances such as venues, lighting, chairs etc. and as these items can be quite costly in numbers alone, we consider safety and wear and tear, repairs and obsolescence factors to serve the greater good of all IRA programs and also use discretionary funds to address these issues as well. We've planned for several years to replace shared equipment without exhausting our fund entirely and were able to accomplish this with the purchase of venue soft goods and risers/seating platforms which were no longer safe as well as a small number of outdated inefficient stage lighting fixtures now replaced with safe, highly energy efficient, non-heat generating fixtures.

Additionally, the sheer number of events often create conflicts based on need and one of those is seating and music stands. When more than one musical event, performance or rehearsals are scheduled, even if they are at different times, we have had to move as many as 100 chairs at a time from venue to venue sometimes more than once a day to support each activity which we've now addressed with discretionary funds by purchasing additional chairs and wheeled racks to store and transport them. These purchases significantly reduced our discretionary funds while allowing us to meet our responsibility to provide comprehensive support directly benefitting the students in our IRA programs. HFA ended the 18-19 year with \$152,363.13 in Discretionary Funds and currently the fund is at \$42,257.30.
