

Dear RN-BSN students:

The Financial Aid and Scholarship Office has prepared this information for you.

RN-BSN students **MAY** be eligible for Pell Grant, Subsidized and Unsubsidized Stafford Loans, Parent PLUS loan, and Alternative/Private Educational Loans. RN-BSN students **ARE NOT** eligible for State University Grant or Cal Grant. RN/BSN Students are encouraged to complete the Wildcat Scholarship application (<http://www.csuchico.edu/fa/scholarships/wildcat.shtml>)

Students with questions regarding their financial aid eligibility are highly encouraged to contact the Financial Aid and Scholarship Office at (530) 898-6451 to schedule an appointment to speak with a Financial Aid Advisor. Chris Trowbridge is an advisor who works closely with the RN-BSN program. However, any advisor can help you. Appointments can be conducted over the phone. Apply for summer 2019 financial aid:

- Complete or update a 18/19 FAFSA (Free Application for Federal Student Aid). [www.FAFSA.ed.gov](http://www.FAFSA.ed.gov)
  - CSU, Chico Title IV School Code 001146
- Notify RCE that you have applied for financial aid to pay summer fees.
- When you have been enrolled in summer courses, complete the summer financial aid application available at [www.csuchico.edu/fa](http://www.csuchico.edu/fa)
- Complete the FAFSA for 19/20 for aid beginning Fall 2019

Important dates:

- March 2nd: Priority filing deadline for the FAFSA
- March 29th: Scholarship deadline for students accepted for the RN/BSN for Fall 2019.
- April 2: Registration opens and Summer Financial Aid Application available
- April 26: Summer Aid Application Priority Deadline to defer fees (Applications submitted by this date will be reviewed and eligibility for aid determined by May 18 or sooner)
- May 17: Summer Fee Payment Deadline (If you are eligible for enough aid to pay your fees, the payment is deferred until financial aid is disbursed.)

**Winter Session: Financial aid IS NOT available for Winter Session courses.**

From Regional and Continuing Education: If you are a Financial Aid student, you must submit a registration request through the Regional and Continuing Education website at <http://rce.csuchico.edu/rn-bsn> so that you can be enrolled, call the Continuing Education Office at 530-898-6105, or respond to this email. Enrollment is **not automatic**. If you are submitting your request via the website above, enter in the comments field that you will be paying with Financial Aid and submitting a Summer Aid application. **Your Aid application must be on file by April 26, 2019.**
