We are proposing to change the name of one of the options under the B.A. in Political Science from "Option in General Political Science" to "Option in U.S. Politics." The old name, General Political Science, does not indicate the focus of the curriculum primarily on U.S. governmental and political institutions, the political behavior of the people of the United States, and political processes specific to the U.S. The core requirements of the major expose students to political theory, comparative politics, international relations, U.S. constitutional law and research methods, and the redesigned Option in U.S. Politics focuses specifically on politics and government in the United States, as the old option did.

We are re-structuring the curriculum of the B.A. in Political Science to bring it into compliance with EO 1071. As part of that re-structuring, we are increasing the common core of classes from 10 to 22 units. The courses that will remain in the old Option in General Political Science will primarily have a focus on U.S. politics, making our proposed new name a better fit.

The old name, General Political Science, also has no relevance or meaning within the broader field of political science. The American Political Science Association and universities in the CSU system and throughout the U.S. and worldwide use U.S. Politics or American Politics to describe this standard subfield within the broader field of political science or politics. For instance, Fresno State, CSU, Fullerton, San Diego State, Sacramento State, UC San Diego, UC Santa Cruz, and other public and private universities in California have options, tracks or subfield requirements in American or U.S. politics within their B.A. in Political Science. Our proposed Option in U.S. Politics is very similar to Fresno State's American Politics Track within their B.A. in Political Science: <http://www.fresnostate.edu/socialsciences/polisci/documents/PLSI%20AP%20track.pdf> (also attached).

AMERICAN POLITICS TRACK

This track is ideal for students interested in **pursuing a career in American politics, including work in campaigns, the government, and supporting elected officials.** (Keep in mind that completion of these courses alone does not fulfill degree requirements.)

Possible careers include working:

- As an elected official in local, state, or national office (many area elected officials are our graduates)
- On the staff of elected officials at the local, state, or national levels working on a wide variety of issues
- As a political campaign organizer and strategist
- In a local, state, and national government department or agency (many senior staff in city or county agencies are our graduates)
- At a nonprofit organization, foundation, or political advocacy organization working on grassroots organizing, social protest, and advocating on social justice issues
- In government relations or lobbying for political interest groups and corporations
- At a newspaper, magazine, film, television, or other media, working on political and governance issues
- At a think tank, research organization, or consulting firm working on local, state, or national political and governance issues
- In education (as a teacher, community college instructor, or university professor)
