Subject: Approval of Significant Changes and a Name Change to the BS in Sustainable Manufacturing

Upon the recommendation of the Academic Senate, with the concurrence of the Provost, and with the approval of the Chancellor's Office, I approve Significant Changes to the BS in Sustainable Manufacturing. The name of the major will change to the **Bachelor of Science in Advanced Manufacturing and Applied Robotics** and the number of units will increase from 90 to 93. The CSU degree program code will change from 09136 to 09991, with a paired CIP code of 15.0613. These changes will be effective fall 2021.
