## Proposal for Minor in Secondary Language Arts

I. Proposed title of new minor: Minor in Secondary Language Arts
II. Academic year of intended implementation: 2021-22
III. Name of the department and college submitting the proposal: English Department, College of Humanities and Fine Arts
IV. Statements on questions of need and demand.
A. Relation of the minor to the University Strategic Plan.

- The proposed minor fulfills the promise of the newly-adopted Strategic Plan by reflecting the importance placed by the English Department on the priorities of Equity, Diversity \& Inclusion, Civic \& Global Engagement, and Resilient and Sustainable Systems. The minor is arranged around advising patterns that provide students with access to diverse program choices, engage with a variety of local and global disciplinary issues, and support resilient future educators who will learn to sustain English Education in coming years.
- The structure of the program, which includes course groupings focused on specific topics within English (General Studies, Creative Writing, Language and Literacy, Literature, and Theatre Arts), provides, provides the opportunity for students to make choices that accommodate their diverse interests in the discipline. Within those choices are courses that focus on issues of diversity, equity, and inclusion, such as ENGL 353 Multicultural Literature, ENGL 364W American Ethnic and Regional Literature, ENGL 436 Cultural Rhetorics, and ENGL 481 Sociolinguistics. Courses such as ENGL 356 Literature, Politics, and Activism, ENGL 438 Professional Writing for Organizations, and ENGL 479 Gender and Language in CrossCultural Perspectives address the discipline's roles in representing, analyzing, and communicating ideas that engage current civic and global issues. Finally, the program's structure and courses taken as a whole envision an approach to the discipline that values not just the acquisition of knowledge about texts, language, and methods, but the recognition of ongoing development in the discipline and the valuing of new voices, new ideas, new literatures, and new approaches - all of which contribute to sustaining the work of the discipline and its relevance beyond the campus.
B. Need for the proposed minor.
- The English Department's BA in English is concurrently being revised (through the Minor Change process) to comply with EO 1071. In order to maintain current options and comply with EO 1071 's greater-than-50\% rule for core vs. option, the proposed revision represents an 18-unit reduction from the current English

Education option. This proposed minor comprises the 18 units that were eliminated from the English Education option. By combining the English Education option with the proposed minor, the California Commission on Teacher Credentialing (CCTC)-approved Subject Matter Preparation Program in English will be maintained.
C. Identify other closely related curricula currently offered by the campus.

- The current Option in English Education meets the current needs of future secondary English teachers. With the revision for EO 1071, a new structure is required to comply with the Executive Order and while continuing to meet the requirements of our CCTC-approved program.
D. Student demand for the minor.
- Approximately half of the approximately 230 English majors select the English Education option, and those students will need the courses in this new minor to earn Subject Matter Competency in compliance with our current approval from the CCTC. This minor will also be available to students interested in pursuing a minor in English that focuses on the discipline's implementation in middle and high school settings, and depending upon the path chosen through the minor, will offer students pursuing teaching credentials in other disciplines with the coursework for introductory and/or subject matter authorizations in English, English Composition, and Literature.

## Subject: Library materials support for the proposed Minor in Secondary Language Arts

The Meriam Library currently holds over 17,000 print titles and 20,000 ebooks in the subject of Secondary Language Arts. The library also subscribes to core journals relating to Secondary Language Arts such as The Modern language journal, Language teaching research : LTR, and Hispania . The foundational database for this program is Literature Online Fulltext (LiOn). In order for this program to be supported, it will be necessary to continue a subscription to this database. Other databases which would also support this program include GALE Literary Studies, Academic Search, OneSearch, JSTOR, MLA International Bibliography, and Project Muse.

The Meriam Library has one 12-month contracted tenure-track librarian whose primary liaison and service area is the Department of English. Another tenure-track librarian serves as backup to this major as needed. A third tenure-track librarian serves at a liaison for Multicultural and Gender Students, which is relevant to this minor.

As it stands now, the library will be able to support the proposed changes outlined in the proposal as all of the courses are preexisting. The library currently supports the Department of English's undergraduate, honors, and master's programs with our existing resources. The new minor being added should be evaluated once the course content is established to ensure their library needs are adequately met.

Ok with that l've got a few suggestions.

In the "choose one" category, I would eliminate THEA 221 and 223 (221 is rarely offered and 223 is a very small class because of the "hands on nature" of a makeup studio). I'd add THEA 170
(Foundations of Design) which is an overview of theatre designers (all areas) and a great introduction to how they operate.

In the "choose three" category, I would make everyone take THEA 250 (Text Analysis) which is a course about how theatre people analyze plays differently than others. I would eliminate THEA 251 (World Theatre), THEA 252 (Politics, Performance \& Power) and THEA 160 (Foundations of Acting). I can explain why if you'd like © With the GE shift, THEA 112 is going back to an "Acting for nonmajors" class, which will be very very helpful. Then, in addition to the courses you listed, I would consider adding THEA 311 (Children's Literature in Performance), THEA 380 (Directing 1)... the prerequisites for THEA 380 are THEA 170 and THEA 250, and if they are both in the track I don't think they'd be considered "hidden prerequisites."

That's my two cents.

I would say that there are a two potential scenarios that this coursework could help students prep for: being asked to lead an extracurricular theatre program, and being asked to teach a course (or courses) in drama/theatre (all English Ed students already have THEA 110 as a GE requirement). And to be frank, we have a dearth of drama-focused literature courses (Shakespeare being the lone exception) on offer, with the two ENGL courses in the list I provided being offered only haphazardly over the past $5+$ years - so giving students some more access to courses like 251, 252, and 354 would be a boon.
