The Faculty Recognition and Support (FRAS) Committee is soliciting nominations to recognize the outstanding faculty of the Chico State community. Please take a moment to nominate an outstanding colleague for any of the following nine awards listed below (see new category highlighted below). *Note:* you may nominate the same candidate for multiple categories; however, two separate and complete nomination packages must be submitted.

To nominate a faculty member, please: 1) fill out the **nomination form**; 2) attach a copy of the faculty member’s **Curriculum Vita**; and 3) submit **three letters of support** (*note:* only three will be viewed, please do not submit more than three). The three letters of support for the nominee should include one from a past or present student, one letter from a faculty member, and a third from anyone looking to support the nomination. These letters should speak to the specific award for which the candidate is being nominated. Prior to award consideration, all nominations will be reviewed by the Office of Academic Personnel (OAPL). Appropriate Deans and Chairs will be notified of the nomination. In the event of a conflict of interest, FRAS Committee Members will not participate in any discussion, evaluation, or voting regarding the award where a conflict is present. No current member of FRAS or Academic Senate Officer may be nominated for an award. Self-nominations are not accepted.

- **Outstanding Academic Advisor Award (OAA):** The objective of this award is to recognize and celebrate lecturers and tenure/tenure-track faculty advising activities of students by fostering student success on campus and in life.
- **Outstanding Early Career Award (OECA):** The objective of this tenure/tenure-track award is to celebrate outstanding teaching, research/scholarship, and/or service for faculty within their first four years at Chico State.
- **Outstanding Faculty Leader Award (OFLA):** The objective of this award is to honor the leadership of a current or immediate past chair, coordinator, or director (*note:* this nomination does not require a student letter).
- **Outstanding Faculty Service Award (OFSA):** The criteria for this lecturer or tenure/tenure-track award includes service to the nominee’s department, college, and Chico State; service to the profession, at regional, national, and/or international levels; service to the community; and demonstrated effectiveness in teaching (*note:* this nomination does not require a student letter).
- **Outstanding Lecturer Award (OLA):** The objective of this lecturer award is to celebrate and encourage excellence in teaching and other assigned academic activities by a lecturer.
- **Outstanding Lecturer in Bringing the Profession to the Classroom (OLBPCA):** The objective of this lecturer award is to recognize faculty’s ability to use real-world, professional experiences to make meaningful experiences for students.
- **Outstanding Professor Award (OPA):** The primary purpose of this tenure/tenure-track award is to recognize outstanding scholarship and/or creative activity of associate and full professors.

- **Outstanding Research Mentor Award (ORMA):** The objective of this lecturer or tenure/tenure-track award is to recognize and celebrate faculty mentorship of student research and creative activities.
- **Outstanding Teacher Award (OTA):** The objective of this tenure/tenure-track award is to celebrate and encourage excellence in teaching.
