INSTRUCTIONAL SUPPORT ASSISTANT (ISA) – Unit 11

- Position:** **Writing Tutors for Fall 2019**
Approximately 5-15 hours per week.
- Job Description:** Under the direct supervision of the Writing Coordinator, the writing tutor will help students understand the writing process and provide them with skills to improve their writing. Tutors may also be asked to lead writing related workshops. Tutors must be prepared to complete at least 10-15 hours of training during each semester of employment.
- Qualifications:** Applicants of *junior, senior or graduate standing* preferred, have a minimum of 2.8 GPA, and have excellent communication skills. Undergraduates must be enrolled in a minimum of 6 units; graduate students 4 grad level units. Applicants should be sensitive to the experience of students from low-income, academically disadvantaged, and ethnically diverse backgrounds. Ongoing participation in training sessions is required for employment.
- Hourly Rate:** \$13.50 per hour.
- Selection Procedure:** Tutors will be selected on the basis of an evaluation of information obtained from the following sources: 1) completed application, 2) unofficial transcripts, 3) interview, 4) instructor's recommendation, 5) at least 4 pages of an academic writing sample, and 6) feedback to sample student essay (this will be emailed to applicants after applications have been reviewed)
- Application Deadline:** Applications will be accepted until all positions are filled.
Interviews will be scheduled as applications are received.
